Dear Green Hardaway Estate Heir,



Unfortunately, the *GHE Organization* has not heard from you after repeated attempts by your Clan Representative and/or me. After attempts to reach out to you via letter/email or phone to convey a proxy-vote option, live-vote at a teleconference meeting or otherwise these last 2 of three 3 quorum meetings, it is being assumed you wish to relinquish your voting rights pursuant to the *GHE Organization*. You are also receiving this letter/notice if you did not respond to the latest request for contributing toward the GHE property taxes. **In any case, please respond to this notice by following the applicable outline and postmark your response no later than Wednesday, October 16, 2013.**

By disregarding this notice, you will be placed in inactive status. As such, you will be required to pay all outstanding fees and penalties if/when you choose to resume active participation, as stipulated by the GHE Quorum. This will eliminate the need for Clan Representatives, other respective members and/or me to constantly contact you to no avail.

By not continuing as an active voting member, correspondence on items and further notices can be done through those applicable and published in the local Gonzales County newspaper.

Mail back the enclosed form with which ever response you deem appropriate for yourself at this time in regard to your retaining active GHE voting status or relinquishing/cancellation of GHE voting status in the quorum setting. Postmark your response no later than Wednesday, October 16, 2013. **Checking more than one option will defer you to Option #3.**

**If you have already sent your \$10 tax payment in regard to GHE property taxes, I will need a copy of your receipt no later than Wednesday, October 16, 2013.**

Please consider that based upon the returns from September 29, 2013, and as a family, we have agreed to enter into contract with certified genealogist Trish Champion of *Champion & Champion* (San Antonio, Texas) and contribute based upon percent-interest (See TX Probate Codes 38 & 45); *Eliza Cline Hardaway Family Group* at roughly 75% and the *Josephine Greenwood Hardaway Family Group* at 25%. As the bill comes due, it will be ascertained as to what financial responsibility each family group is to pay.

## **GHE Active/Inactive Status Report**

Checking more than one option will defer your selection to Option #3.

### **OPTION I**

I will continue/resume participation in *GHE Quorum* meetings and actively vote by proxy or live vote (via teleconference or physical meeting). Additionally, I will send a money order for \$10 (minimum) to cover my portion of property taxes to be applied to the Green Hardaway Estate; and finally, indicate (below) the two Texas-residents (one from the *Eliza Cline Hardaway* & the other from the *Josephine Greenwood Hardaway Family Group*) I wish to see as authorized/designated signatories on the GHE financial account/s. I also acknowledge I am obligated to participate in any financial endeavors that are voted on and passed by the *GHE Organization*. I further acknowledge that if I do not include the tax payment (minimum of \$10) in the forwarding of my active/inactive report response my status will automatically default to OPTION III and an inactive status relative to quorum meetings/voting will apply.

### **OPTION II**

My voting interest is to be exercised by my *GHE Clan Representative*. I understand I am also obligated to issue a written statement designating my Clan representative as my voting-agent (to include the date and my authorizing-signature). Additionally, I acknowledge my responsibility to send a money order for the \$10 (minimum) contribution to GHE property taxes. I understand that if the Clan Representative does not receive the above described written notice OR \$10 contribution my member's status will automatically defer to inactive status and result in the inability to vote in the quorum setting. Finally, I acknowledge I am obligated to participate in any financial contributions that are voted on and passed by the *GHE Organization*.

### **OPTION III:**

I relinquish my voting interest. I also understand that failure to respond to this letter and/or poll results in inactive voting status. Additionally, I relinquish my participation in the *GHE Quorum* setting, ie. I am not permitted/able to cast a vote regarding items of the estate. I am considered an inactive, but verified, member of the *GHE Organization* having submitted my vital documentation to protect my heirship interest in the Green Hardaway Estate. I understand that my active status can be reinstated by meeting/contributing the \$10 (minimum) apportionment for GHE taxes and making the organization whole by contributing my portion of any outstanding individual/financial obligation(s) voted on and passed by the *GHE Organization* since active status was lost.
